MARCH 1, 2022 9:00 AM  
MEADE COUNTY COURTHOUSE**

THE BOARD OF MEADE COUNTY COMMISSIONERS MET AT 9:00 AM. RANDY LEIS, JANNA FRYDENDALL AND CLAIR BENDER WERE IN ATTENDANCE, ALSO PRESENT WAS JANET HALE, MEADE COUNTY CLERK.

LEIS CALLED MEETING TO ORDER AT 9:00.

LEON REIMER JOINED THE MEETING. REIMER PRESENTED THE 2022 KIMBALL MAPPING CONTRACT FOR APPROVAL.

FRYDENDALL MADE A MOTION TO APPROVE THE 2022 KIMBALL MAPPING CONTRACT. BENDER SECONDED AND THE MOTION CARRIED 3-0.

BRYAN BURGESS JOINED THE MEETING.

BURGESS PRESENTED A LETTER TO BE SIGNED BY THE CHAIRMAN, DESIGNATION BURGESS AS ADMINISTRATOR FOR ARPA. LEIS SIGNED THE LETTER AND HALE NOTARIZED IT.

RANDY BLEHM AND STAN SHEWEY JOINED THE MEETING. DISCUSSION WAS HAD ON PERHAPS DOING A LEASE FOR THE CONCRETE ROAD AND THE OVERLAY ROAD IF NEEDED. SHEWEY EXPLAINED HOW THE LEASE WOULD WORK.

BLEHM PRESENTED HIGHWAY PERMIT 2-2-22 FOR APPROVAL.

LEIS MADE A MOTION TO APPROVE HIGHWAY PERMIT 2-2-22 AS PRESENTED. FRYDENDALL SECONDED AND THE MOTION CARRIED 3-0.

DOUG RITTER JOINED THE MEETING. RITTER EXPLAINED THAT THERE WOULD BE AN OVERAGE ON THE 2 GRANTS HE IS RECEIVING AND WOULD LIKE TO SPEND \$35,000 OF IT ON PURCHASING 2 MORE CONSOLES FOR DISPATCH. THIS WOULD ALLOW DISPATCH TO COMMUNICATE WITH SHERIFF, FIRE AND EMS AND WOULD ALSO ALLOW THEM TO GET RID OF UHF.

RITTER ADVISED THE COMMISSIONERS THAT THE PART-TIME JAIL NURSE WOULD START MARCH 21<sup>ST</sup>.


HALE PRESENTED ABATEMENTS 00010 THRU 00012 FOR APPROVAL.
